

Big Bacon Giveaway Rules and Regulations

The Big Bacon Giveaway Contest (The “Contest”) through Red Barn Market is intended to be conducted in Canada only and shall be construed and evaluated according to applicable Canadian law. No purchase necessary.

ELIGIBILITY

To be eligible for this Contest, an individual must be a legal resident of the province of British Columbia.

Employees of Red Barn Market and the household members of Red Barn Market employees, are not eligible to participate in the Contest.

Red Barn Market shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to Red Barn Market for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

CONTEST PERIOD

The contest begins at 6:00 a.m. Pacific Standard Time on August 31, 2023 and ends at 11:00 p.m. Pacific Standard Time on September 30, 2023 (the Contest Period) after which time the Contest will be closed and no further entries shall be accepted.

HOW TO ENTER

- (a) In order to win this contest, the participant must find 1 of 10 golden tickets hidden in a pack of Red Barn Market’s Double Smoked Bacon strip product.
 - a. To submit your entry the winner must email their ticket number to contest@redbarnmarket.ca and present the ticket when claiming the prize.
 - b. Tickets will only be accepted until 11:00pm on September 30th, 2023.

All entries become the sole property of Red Barn Market and none will be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. No communication or correspondence will be exchanged with entrants except with those selected for each Gift Basket prize.

PRIZE

There are ten (10) Bacon prizes available to be won by the Prize winner (each a Winner) each consisting of a gift card. This is for the purchase of one 375G package of Red Barn Smokehouse Double Smoked Bacon, per week, for 52 weeks.

Value of the gift is \$520 (excluding taxes).

The Prize winner(s) shall not be entitled to receive, in cash, product or otherwise, the balance of any amount representing the difference of the Prize retail value and actual cost.

Prize(s) will be distributed within seven (7) days after the winner has successfully claimed and notified of Red Barn Market of his/her prize and fulfilled the requirements set out herein and ticket has been verified.

WINNER SELECTION

- (a) 1 of 10 tickets will be distributed randomly in a pack of Red Barn Market Double Smoked Bacon, within the week of August 31-September 6th. Whoever finds (one of) the Red Barn Market golden tickets will be the winner.

If the winner does not present their winning ticket by September 30th 2023, they will not receive their prize.

All legitimate golden tickets will have a unique identifier set by Red Barn Market, eliminating the chance of false replication.

CONDUCT

By participating in the Contest, each entrant agrees to be bound by the Contest Rules, which will be posted on the redbarnmarket.ca website and/or made available at each Red Barn Market location in Victoria BC throughout the Contest Period.

Red Barn Market reserves the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest, the redbarnmarket.ca website; (c) acting in an unsportsmanlike or disruptive manner.
